## CLIENT AGREEMENT

### Email Tarot Reading Experience & Commitment

*I am truly honored to support you in this exploration with the tarot as our guide.  
There are some important things to cover before we can dive in...*

**MY COMMITMENT TO YOU:** When conducting a reading for you, I commit to be fully present, focused, and free of any distractions or disruptions, so I can fully expand my energy, and deeply connect to my intuition, higher self, and other supportive beings of light.

**YOUR COMMITMENT AS A CLIENT:** To gain the most insight and value from your reading, it's important to have a core question you would like to focus on. The most powerful questions are open ended (not answered with "yes" or "no").

**Some example questions could start like this:**

- How can I...
- What is important for me to know about...
- Why am I experiencing...

*(After receiving your question, I may reach out to ask you some clarifying questions, if that feels necessary.)*

### WHY WOULD I WANT AN EMAIL READING & WHAT'S IT LIKE?

Email readings, simply put, are amazing - even better than an in person reading! I can do your reading when I'm in my prime energetically. And you don't need to go anywhere. Win-win!

Another amazing bonus to email readings is the gorgeous 8-10 page PDF document you'll receive analyzing your whole reading. It's full of images and descriptions about the different cards that you can refer back to at any time. No pressure to remember all the juicy details!

My intuition is my main guide, however I still include the more traditional card meanings as well if it feels applicable. I **DO NOT** tell you your future. I believe in freewill, and your ability to shape your own destiny. The Tarot cards offer guidance, but nothing is ever set in stone. **You are the creator in your life.**

I spend a great deal of time preparing for your reading. After feeling into your question, I create a custom spread just for you. I may add some additional questions to expand some aspects of your reading further.

When I feel fully energetically available (in my prime level of connection), I create a sacred space focused around the essence of your question. I use a variety of crystals to clear & support the energy of the space and the deck that feels most aligned with your question. Pictures of this are included in your reading document.

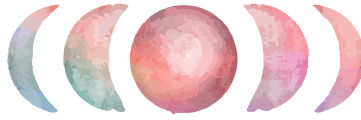

I draw the cards based on the spread I designed for you and begin to connect to the messages they are offering, how they relate to each question in your spread, and connect to your core question. I also pull an oracle card after the reading for you to feel into with your own intuition. Many times, what you see in it is more powerful than what the book says. If you would like the meaning of that card provided, just ask and I'll send it. However, I encourage clients to allow themselves to feel into what message they get from it first.
